## **AGENDA ITEM: 2.**

## **REVISED APO FOR FINANCIAL YEAR 2021-22**

The CPD cum Member Secretary apprised that in the 5<sup>th</sup> Governing Body Meeting APO for the Financial Year 2021-22 was approved for Rs 64 Cr. Now, as per the allotment of funds by HPFD, the revised APO for Rs 45 Cr have been prepared and placed before the Governing Body as **Annexure B**. The revised APO was deliberated upon budget line-wise.

PCCF (HOF) suggested that for some of the specific activities, more funds beyond 45 Crores can be allotted if required and execution of such activities can be done in anticipation of the approval by GB. However the same may be got ratified in the next GB Meeting.

Decision: The Governing Body approved the Revised APO for Rs 45 Cr.

# ADOPTION OF 'JAL BHANDARAN SCHEME' OF HPFD IN JICA FORESTRY PROJECT

The Governing Body was apprised about the "Jal Bhandaran Scheme" of the HPFD and its adoption for PIHPFEM&L. It was further appraised that sites has been selected under 'Jal Bhandaran Scheme' for 2021-22 out of the funds provided for PIHPFEM&L (JICA Funded). Since the scheme is to continue for next 3-4 years and PIHPFEM&L (JICA Funded) will also to be a part of the "Scheme", as such the Governing Body was requested to approve the adoption of the scheme in PIHPFEM&L (JICA Funded).

<u>Decision:</u> The Governing Body approved adoption of "Jal Bhandaran" scheme of HPFD in PIHPFEM&L (JICA funded).

## **AGENDA ITEM NO.4**

## PROCUREMENT FOR VFDS PFM MODE ACTIVITIES, NORMS THEREOF;

The CPD, JICA Forestry project presented the details of the VFDS/BMC sub-Committees under the JICA Forestry Project. He underlined that 400 VFDSs, 60 BMC sub-committees and 920 SHGs are to be constituted out of which 317 VFDSs (77 in Batch I, 182 in Batch II and 58 in Batch III), 46 BMC sub-committees (12 in Batch I & 46 in Batch II) and 445 SHGs (158 in Batch I & 287 in Batch II) have been constituted. As per the project requirement, the funds pertaining to the PFM modes activities are transferred to the VFDS accounts which are registered under "HP Societies Act". These community based organizations has to engage themselves in various procurements and execution of various activities under PIHPFEM&L (JICA Funded) such as plantation, SMCs works, petty small civil works, procurement of goods and equipment for IGAs and also services for accomplishment of various project activities/interventions under PFM mode.

The GB was appraise that with a view to streamline and simplify the process of execution and procurement by the VFDS/BMC Sub-Committees, standard procurement procedures and guidelines for VFDS/SHG/BMC to implement PFM activities and Livelihood activities under PIHPFFEM&L, a Committee was constituted under the chairpersonship of Conservator of Forest & Project Director( M&E) along with Project Director ( A&F), Finance Officer as members to work-out the modalities for community procurement by VFDSs/ BMC Sub Committees/SHGs. The recommendation of the committee was deliberated upon & it was decided by GB that the HPFD Procurement Procedure should continued to be followed for all such procurements by VFDSs/BMCs/SHGs etc. However it was desired by ACS (Forests) and the Chairperson that HoFF will review the report again at his level & if needed the same be sent to ACS(Forests) for approval on single file.

Decision: After the due deliberation Chairperson desired that the existing departmental procurement procedure be followed for all kind of Procurement under PFM & Departmental mode. However HOFF will review the report again at his level & if needed the same be sent to ACS (Forests) for approval on single file.

## **AGENDA ITEM: 5.**

# ADOPTION OF HPFD NORMS FOR THE MAINTENANCE OF THE PIHPFEM&L PLANTATIONS:

Governing Body was appraised that area of 10984 ha has to be covered under the plantations in all the three batches of 18 Divisions under the Project in both PFM as well as Departmental mode. The models prescribed for plantation under the Project document are as under:-

- 1. Afforestation @ 1100 plants/ha and 800 plants/ha (Normal Plants)
- 2. Tall Block plantation @ 500 plants/ha (Tall Plants)
- 3. Assisted Natural regeneration @ 200/ha (Tall Plants)

In the cost breakdown component of the Project document provision of budget has been kept @ 10% and 5% for maintenance of all plantations for 1<sup>st</sup> and 2<sup>nd</sup> year only which is not in consonance with the HPFD provisions for the similar plantations maintenance activities. Whereas the HPFD norms for Plantation in Project for Improvement of Himachal Pradesh Forest Ecosystems Management & Livelihoods are being followed, therefore HPFD Norms notified by PCCF (HoFF) for maintenance of plantation are required to be adopted in the Project for Improvement of Himachal Pradesh Forest Ecosystems Management & Livelihoods (PIHPFEM&L).

Decision: The Governing Body approved the agenda as such.

## **AGENDA ITEM NO. 6**

## **INCOME GENERATION ACTIVITIES (IGA) MODELS**

The CPD, JICA apprised the GB that as on date 445 SHGs/ CIGs are formed in the Batch I&II under the project. Most of the SHGs/CIGs are strengthen and prepared business plans by adopting different IGA models.

It was further apprised by CPD JICA that different livelihood cost models namely Badi making, Beekeeping, Seera making, Ginger Garlic paste, Haldi powder, mushroom farming, Paneer making, Pickle& powder making, Chulli oil extraction & Vermi Composting has been prepared by PMU team & which are being adopted by SHGs/CIGs under the Project. All the models were discussed & approved by GB.

Decision: Governing Body approved all the Ten proposed Income Generation Activities Cost models.

# JADI BUTI CELL PROGRESS OF THE MODELS APPROVED BY GOVERNING BODY AND NEW MODELS FOR APPROVAL:

The Governing Body was appraised about the progress made by Jadi-Buti cell and the work being done on previously approved models. The GB was appraised that four new models have been proposed to be implemented in the field.

Decision: The Governing Body approved all the four new models as such.

## **AGENDA ITEM: 8.**

## **HIRING OF VEHICLE FOR DMU LAHAUL:-**

The Governing Body was apprised that the DMU Lahaul was not provided vehicle in the first go because the ranges of DMU Lahaul falls under Batch-II & III where now all the necessary activities (Plantation Advance-work, Identification and selecti on of Communities, Preparation of Micro Plans, etc) has been started. DMU Lahaul has made a request to provide one vehicle to DMU Lahaul for mobility of the field staff for Project activities. CPD further explained that there is a provision for "Hiring of Vehicle" in Component: 4 (4.1.2.1) under Institutional Capacity Strengthening (Mobility Support).

Decision: The Governing Body approved the hiring of one Vehicle (Bolero) for DMU Lahaul at the rates approved by Deputy Commissioner.

## PROPOSAL OF RATES FOR HIRING OF 16 BOLERO CAMPER/EQUIVALENT UTILITY VEHICLES FOR BATCH-I RANGES UNDER JICA-PIHPFEM&L:-

The Governing Body was apprised that the previous rates of Rs. 35,000/-, which were proposed for the hiring of the Bolero Camper/equivalent utility vehicle, are not competing with the current market scenario and the practical issues like hike in POL (Petroleum, Oil, & Lubricants) prices has made the service providers reluctant to provide the aforesaid vehicles for the Project (PIHPFEM&L). Also, there are no rates of aforesaid vehicles approved by Deputy Commissioners (DCs) of the Project area.

CPD further mentioned that the Project activities has been started in all the 61 Project Ranges, therefore vehicle is essentially needed for these ranges to expedite the Project activities.

The Chairperson was of the view that "Bolero" be hired for all the Ranges in place of "Bolero Camper".

Decision: After deliberations, the Governing Body approved the hiring of "Bolero" in place of "Bolero Camper" at the rates approved by the Deputy Commissioner of the area for all the 61 Project Ranges.

## **AGENDA ITEM: 10.**

#### **NEED FOR MORE STAFF**

## (a) GIS AND MIS EXPERT:

The Governing Body was apprised that one GIS cum MIS Expert is required for Project for Himachal Pradesh Forest Ecosystems Management & Livelihoods for further enhancement of GIS and MIS based infrastructure with an objective:

- 1. To manage all the aspects associated with the need for mapping and preparation and maintenance of Project Information System.
- 2. Provide support to develop Web-based MIS system for the project to prepare and consolidate of periodical Project Progress Reports.

Detail role and responsibility of GIS cum MIS expert was defined and placed before the Governing Body to for consideration and Approval

<u>Decision:</u> After deliberations, Governing Body decided that the services of an IT expert at local level to develop MIS base software and then its integration with GIS be hired. The Chairperson also directed to hire services of Social Development and Livelihoods expert under the Project for the implementation of Livelihoods activities, promotion of income generation at cluster level and coordinate with project stakeholders. It was also decided that the TORs for hiring the proposed IT and Social development / Livelihoods Experts be prepared and got approved separately on single file.

#### (b) PUBLICITY EXPERT:-

The GB was apprised that the services of one Publicity Expert are essentially required in the JICA assisted PIHPFEM&L, who will deal with the I.E.C. Material, Translation of various documents in Hindi as well as in English, Liaise with Representatives, Government officials and Media as required, Communication Activities by Drafting Press releases, Talking points, assist in the preparation of any relevant reports, household surveys, customer surveys, evaluation exercise etc. for the Project and Preparation & Dissemination of Communication Collaterals as needed including brochures, posters, handout, audio-visual material etc.

Decision: The Governing Body approved to hire the services of one Media Specialist on fixed emoluments @ Rs. 60,000/- per month.

## (c) RETIRED SR. ASSISTANT/SUPERINTENDENT

The GB was apprised that there is only one JOA-IT working in the PMU Office Shimla who is on deputation from HPFD and he is looking all the correspondence related to establishment Branch, Store Branch and other Ministerial works. HPNRMS Solan is deploying the remaining staff to JICA-PIHPFEM&L, therefore the services of one Retd. Sr. Asstt/Supdtt. is required for PMU Office. Similarly the services of one Retd. Sr. Asstt./Supdtt. is required in the Projects Branch O/o Pr. CCF (HoFF) to deal with the correspondence pertaining to JICA assisted PIHPFEM&L.

Decision: After deliberations the Governing Body approved to hire the services of two Retd. Sr. Asstt./Supdtt. on fixed emoluments @ Rs. 25,000/- per month, who will work under the direct supervision of PMU Shimla.

HIRING THE SERVICES OF SH. SITA RAM, RTD. DY. RANGER AS NURSERY EXPERT:-

The GB was apprised that as requested by DFO Theog, the services of Sh. Sita Ram, Retd. Dy. Ranger as Nursery Expert are required to be hired in Theog Forest Division. It was further apprised that Sh. Sita Ram has vast experience in Nursery Development and has won many prizes in his service time. Hiring his services can boost the modern nursery development approach of HPFD.

Decision: The Governing Body approved the hiring of the services of Sh. Sita Ram, Dy. Ranger Retd. initially for a period of one year. The GB also approved the fixed emoluments of Rs. 25,000/- per month for the services of Sh. Sita Ram, Retd. Dy. Ranger.

# ANNUAL PROGRESS REPORT (APR) OF THE PIHPFEM&L(JICA FUNDED) FOR FY2019-21 & FY2020-21

The GB was appraised that as per Project documentation process, the APRs of the PIHPFEM&L (JICA Funded) for the FY 2019-20 & FY 2020-21 have been prepared and are placed as copies. The Reports, in addition to the details of the Project, contains, activities done in the said financial years, financial outlays, reimbursement claim status, Jadi –Buti Cell activities, GIS& MIS activities, plantations, livelihood activities etc.

Decision: - The Governing Body appreciated the preparation and updating of the documentation process.

# ESTABLISHMENT OF LIVELIHOOD RESOURCE CENTRE ( LRC) AT CLUSTER LEVEL

The GB was appraised that as a lesson learnt from the similar JICA funded Forestry Projects in other States of the Country, there is a need to establish Livelihood Resource Centers for imparting trainings to the SHGs. The establishment of Livelihood Resource Centre (LRC) would provide the specialized business promotion support for business planning, marketing, product development and facilitating linkages with financial institutions and other resource organizations. It would also provide support at cluster level to SHGs for IGAs. These LRCs would surely be an add on for inclusive growth of the stakeholders. In the first go, one LRC at Mandi, as pilot will be created and subsequently would be extended across the other locations after due analysis in future.

The GB was apprised that for the purpose, a structure, may be pre-fabricated, needs to be constructed where trainings to SHGs can be provided on various IGAs, having capacity of minimum 50 persons with necessary training aids, furniture etc. The tentative cost proposed was Rs. 35 Lakh for which the chairperson had a view that the cost can go higher. The CCF Mandi pleaded for establishment of LRC at Mandi and assumed that the site for the same will be selected with in 5Km radius of MC Mandi limits. The chairperson suggested that the site can be near to Nagar Van/Vatika. One of such site was suggested at Devi Dhar Mandi.

Decision: - The Governing Body approved the proposal for establishment of one Livelihood Resource Centre at Mandi.



### RATIFICATION OF MOU WITH HPSRLM

The Member Secretary apprised the GB that The Department of Rural Development & Women & Child Welfare Department (WCD) of GoHP is forming the SHGs (Self Help Groups) of the poor communities & necessary trainings & support is also being provided to the SHGs from HPSRLM (Himachal Pradesh State Rural Livelihood Mission). The similar approach is also being followed under "Project for Improvement of Himachal Pradesh Forest Ecosystems Management & Livelihoods" (PIHPFEM&L-JICA Funded). It was appraised that till date 445 SHGs have been formed in the Project area & approximately 98 SHGs have started the income generation activities. To have convergence, a meeting in this regard under the Chairmanship of ACS (Forests) was held on 2<sup>nd</sup> Sept 2021,in which apart from other decisions, it was decided to make use of the HIMIRA shops for selling the various products of SHGs under the Project (PIHPFEM&L-JICA Funded).A sequel to this a meeting was also held under the Chairmanship of Chief Secretary on 28th Sept 2021 and It was decided to have a common platform for sale of products being made by SHGs as their income generation activities

The GB was appraised that for furtherance of the above, HPSRLM has agreed in principle to make available HIMIRA shops as well as online platform for marketing and branding of the products being made by the SHGs of PIHPFEM&L to have more transparency. A MoU (Memorandum of Understanding) has been finalized and the Chairperson and the GB appreciated the progress made in this direction.

Decision: - The Governing Body approved the proposal as such.

## AGENDA ITEM: 15 (DEFERED ITEM OF 5<sup>TH</sup> GB TO 6<sup>TH</sup> GB)

## SALARY CORRECTION FOR PIHPFEM&L (JICA Funded) OUTSOURCED STAFF.

Proposal to enhance the emoluments of PIHPFEM&L (JICA Funded)\_outsourced staff was placed before the GB for consideration and approval.

A comparative analysis of remuneration of personnel on similar designations in other Departments and States, for bringing in normalization of salary structure at par with organizations was also placed before the Governing body.

Decision: The Governing Body approved salary structure of following categories w.e.f 01.01.2022.
